### 2. **BTNEP & LDWF to offer state-wide summer workshops on LA wetlands**

The Barataria-Terrebonne National Estuary Program is partnering with the Louisiana Department of Wildlife and Fisheries to announce its free summer wetland teacher training workshops for educators who teach grades K-4. The Louisiana Department of Wildlife and Fisheries is also offering stipends to teachers who participate in the training. K-4 teachers can learn more about Louisiana wetlands through these interactive "Coastal Curricula Workshops" Teachers will receive information and instruction on Louisiana's wetlands during this **one-day** workshop. Lessons and activities are aligned with GLES and can be incorporated into the current curricula. These workshops will help teachers learn what teachers and students can do to help Louisiana wetlands. Each participant will receive lots of classroom materials.

#### Fixing the Mississippi: A Mighty Challenge

Most know that to restore and rebuild Louisiana's wetlands will require massive-scale reengineering of the Mississippi River, putting the old man's land-building potential to work. But the Mississippi's problems aren't all at it's tail, and any honest effort to help restore the river's natural systems is going to mean a lot of work.
