### **Regional Planning Team (RPT) Coastwide Voting Meeting**

The RPTs will select three projects in the Terrebonne, Barataria, and Pontchartrain Basins; two projects in the Breton Sound, Teche/Vermilion, Mermentau, Calcasieu/Sabine, and Mississippi River Delta Basins and one project will be selected in the Atchafalaya Basin. If only one project is presented at the RPT Meeting for the Mississippi River Delta Basin, then an additional nominee would be selected for the Breton Sound Basin. If coast-wide projects have been presented, the RPTs will select one coast-wide project nominee. In addition, the

RPTs will select six demonstration projects for further evaluation.
