- 1. ALL ELEVATIONS ARE GIVEN IN THE NORTH AMERICAN VERTICAL DATUM OF 1988 (NAVD 88). ALL HORIZONTAL COORDINATES ARE GIVEN IN THE NORTH AMERICAN DATUM OF 1983 (NAD 83).
- 2. THE CONTRACTOR SHALL BE RESPONSIBLE FOR NAVIGATING WITHIN THE LIMITS OF THE PROJECT PLAN AREA. THE ENGINEER OR HIS REPRESENTATIVE SHALL MONITOR THE LOCATION DURING CONSTRUCTION. ALL EQUIPMENT SHALL BE FLOATING AT ALL TIMES. DREDGING IS PROHIBITED.
- 3. THE CONTRACTOR SHALL NOT, AT ANYTIME, TREAD ON EXISTING MARSH OR VEGETATIVE WETLANDS UNLESS OTHERWISE DIRECTED BY THE CPRA PROJECT ENGINEER.
- 4. THE CONTRACTOR SHALL BE RESPONSIBLE FOR REMOVING AND REPLACING ALL WARNING SIGNS ON TE-0022 STRUCTURES 1, 2, 3A, 6, 7, AND 8 & BA-0002 STRUCTURE 4A. THE CONTRACTOR SHALL REMOVE AND DISPOSE OF ALL EXISTING WARNING SIGNS OFFSITE
- 5. THE CONTRACTOR SHALL REPLACE EXISTING TE-0022 WARNING SIGN SUPPORT WHERE DAMAGED ON STRUCTURES 3A AND 6 (TWO SUPPORT POLES EACH).
- 6. THE INTERIOR WATER IN POINTE AUX FER WILL LIKELY BE TOO SHALLOW TO ALLOW ADEQUATE DEPTH FOR HEAVY MACHINERY TO DRIVE POLES.
