This addendum shall be considered part of the Contract Documents (except as noted otherwise) and is issued to change, amplify, or delete from or otherwise explain these documents where provisions of this addendum differ from those of the original documents. This addendum shall have precedence over the original documents and shall govern.

I. Advertisement for Bids

The Bid Opening for the Grand Liard Marsh and Ridge Restoration Vegetative Plantings Project (BA-0068) will proceed as scheduled. However, per Executive Order of the Governor, all State Offices have been closed to the public due to COVID-19 and bidders will not be allowed to attend in person. Bids will still be received for the State of Louisiana by the Coastal Protection and Restoration Authority at 150 Terrace Avenue, Baton Rouge, Louisiana 70802 until 2:00 P.M., Tuesday, April 21, 2020. If you choose to hand-deliver your bid, a station to receive bids will be located at the front entrance to the CPRA Building (north side). Bids can still be delivered via United States Mail or express delivery as long as they are received no later than 2:00 P.M. on Tuesday, April 21, 2020. The bid opening will be broadcast live via webinar immediately following the 2:00 P.M. deadline as outlined in the Bid Documents. II. Responses to Questions Submitted by Contractors

Contractor Question/Comment (1): How many trees with 3” caliper or bigger at Nicholls facility that needs to have 3 guide wires attached to tree and staked into ground.

CPRA Response (1): *There are currently no trees requiring guide wires.*

Contractor Question/Comment (2): Does pile removal have anything to do with the planting project?

CPRA Response (2): *No.*

Contractor Question/Comment (3): Do the plant lines need to be surveyed in or roughly positioned?

CPRA Response (3): *The plant lines do not need to be surveyed in, as long as the spacing and general alignment described in the Plans and Specifications are met.*

Contractor Question/Comment (4): Do the plants need to be purchased or are they provided by CPRA?

CPRA Response (4): *The CPRA is providing the plants.*

Contractor Question/Comment (5): Does the fertilizer need to be purchased or is it provided by CPRA?

CPRA Response (5): *The fertilizer needs to be supplied by the Contractor.*

Contractor Question/Comment (6): Can 1" x 1" stakes be used?

CPRA Response (6): *No, as per Specification TS 1001.5.1 stakes shall be 2" by 2" square.*

Contractor Question/Comment (7): Where can the tree protectors and tags be purchased?

CPRA Response (7): *The CPRA does not require these items to be purchased from a specific vendor nor does CPRA have a list of vendors to provide these. It is required of the Contractor to procure the materials to complete the contract and meet the requirements set forth in the Contract Documents.*

Contractor Question/Comment (8): The contact at Nicholls, Jenny Schexnayder, does not know the cost of the plants. Do you know the cost?

CPRA Response (8): *The CPRA is providing the plants.*

Contractor Question/Comment (9): Is there any idea of when the project will be expected to start?

CPRA Response (9): *The CPRA will comply with the timeframes stated in LA. R.S. 38:2215.*

III. Revised Louisiana Uniform Public Work Bid Form

The Louisiana Uniform Public Work Bid Form has been revised. The Bidder should refer to Attachment A for the revised form. Bidders must use this Revised Bid Form in the submission of their bid.

IV. Revision to Technical Specifications and Plan Sheets

Technical Specifications

Modifications to Technical Specification section TS-1220.2 are represented by bold, italicized text and are replaced in their entirety with the respective section below:

- 1220.2 **Tree Protector Installation:** The Contractor shall install Tree Protectors to protect trees from nutria and other wildlife. Tree Protectors shall be three (3) to five (5) inches in diameter and ***heights as follows: 750 protectors of sixty (60) inches, 1,900 protectors of thirty (30) to forty-eight (48) inches, and 2,000 protectors of eighteen (18) inches. Some protectors may still require minor modification during installation.***
- 1220.2.1 Stakes shall be a minimum of six (6) inches longer than the Tree Protectors. The Contractor shall install stakes with a stake driver. The stakes shall be installed to a depth so that the top of the stake is several inches higher than the zip tie that secures the protector to the stake. The stake should be installed on the side of the tree toward the prevailing wind.
- 1220.2.2 Tree Protectors shall be secured around the tree with the re-sealable tabs near the top, middle and bottom of the trunk in a manner so as not to restrict or damage the bark. Tree Protectors shall be pushed into the ground two (2) to five (5) inches to prevent nutria from burrowing under the protectors.
- 1220.2.3 Tree Protectors shall be doubled around approximately 1,000 trees (275 of which will be eighteen (18) inches in height and the remaining 725 will be thirty (30) to forty-eight (48) inches in height). These additional protectors are included in the bid quantity on the Louisiana Uniform Public Work Bid Form.***
